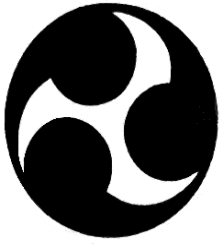

# WILMINGTON KARATE TOURNAMENT RULES

## KATA COMPETITION.

1. CONTESTANT MUST BOW BEFORE ENTERING OR LEAVING RING.
2. CONTESTANT WILL BOW TO JUDGES AND STATE THEIR NAME, STYLE, AND FORM.
3. CONTESTANT WILL PRESENT KATA BOW AND WAIT FOR JUDGES TO SCORE KATA.
4. KATA WILL BE JUDGED ON POINT SYSTEM WHERE 10.0 IS HIGHEST SCORE.
5. JUDGES WILL SCORE BASED ON PRESENTATION, TECHNIQUE, BALANCE, AND POWER.
6. FIVE JUDGES WILL SCORE KATA, HIGHEST AND LOWEST SCORE WILL BE DROPPED. IN IN CASE OF A TIE THE LOW SCORE WILL BE ADDED, IF STILL TIED HIGH SCORE WILL BE ADDED.

## SPARRING COMPETITION.

1. SPARRING MATCHES WILL BE THREE MINUTES, OR THREE POINT WHICHEVER COMES FIRST.
2. A POINT IS EARNED FOR A FOCUSED BLOW TO LEGAL TARGET. IF TARGETING HEAD BLOW MUST BE FOCUSED ONE INCH FROM TARGET FOR GREEN & UNDER.
3. LEGAL TARGETS ARE HEAD, RIBS, CHEST, ABDOMEN, GROIN, AND KIDNEYS.
4. ILLEGAL TARGETS ARE SPINE, LEGS & KNEES.
5. A HALF POINT WILL BE AWARDED FOR SWEEPS THAT TAKE OPPONENT DOWN GREEN BELT AND ABOVE ONLY.
6. SWEEPS MAY ONLY BE FOOT TO FOOT.
7. IF EITHER OPPONENT GOES TO GROUND EITHER OPPONENT HAS FIVE SECONDS TO SCORE POINT. IF NEITHER SCORES POINT WITHIN THE FIVE SECONDS MATCH WILL STOP.
8. ONE WARNING FOR OUT OF BOUNDS. ON SECOND OUT OF BOUNDS POINT WILL BE GIVEN TO OPPONENT.
9. IN CASE OF EXCESSIVE CONTACT POINT WILL BE GIVEN TO OPPONENT. ON SECOND EXCESSIVE CONTACT CONTESTANT WILL BE DISQUALIFIED.
10. IN CASE OF TIE AT END OF MATCH, THE MATCH WILL CONTINUE UNTIL NEXT POINT SCORED.
11. UNSPORTSMANLIKE CONDUCT WILL NOT BE ALLOWED. CONTESTANTS, PARENTS, AND FANS PLEASE SHOW PROPER RESPECT TO JUDGES & COMPETITORS. NO NEGATIVE COMMENTS, OR COACHING.
12. SPARRING EQUIPMENT MANDATORY. EQUIPMENT MEETING NASKA, IKSA, AND WKF WILL BE ALLOWED.
13. NASKA SPARRING UNIFORM RULES APPLY.

## WEAPONS SPARRING.

1. ALL SPARRING RULES APPLY
2. POINTS MAY BE SCORED WITH WEAPON, HAND OR FOOT TECHNIQUE
3. FOR WEAPON TECHNIQUES ADDITIONAL TARGETS ARE HANDS, AND SIDE OF SHINS.
4. SPARRING WEAPONS WILL BE PROVIDED.
5. WEAPONS THAT MAY BE USED BO, SAI, TONFA, NUNCHAKU, KAMA, SWORD, NUNTIBO, SURUJIN, TRISECTIONAL STAFF, & ESCRIMA.
